*----Buyer will pay all shipping and miscellaneous charges associated with transport of both the puppy back to the seller, and the replacement puppy back to buyer.*

*----All shipping and transportation expenses are the responsibility of the BUYER.*

*2./ Seller shall not be held responsible for the development of disqualifying faults, diseases, viruses, or disorders, which are due to the Buyers negligence.*

## **HEALTH GUARANTEE:**

*1./ Seller guarantees that the said puppy is in good health condition to the best of her knowledge. All puppies are health checked before leaving to their new homes. Seller will provide buyer with medical records, detailing treatment he/she has received under seller's care, and any future care that the seller feels is essential to the puppy's well being.*

*2./ Seller guarantees that the Puppy is free of life threatening diseases or disabilities to her knowledge at time of change of ownership.*

*3./ At no time will the Seller be responsible or obligated to pay for Veterinary Treatments that are not agreed upon IN ADVANCE.*

*4./ This guarantee does not cover common ailments, and disorders that are common to the breed, such as (kennel cough, giardia, coccidiosis, parasites, demodex, hernia, hips, patella, and cherry eye.*
